### Seal Information

The Ballot Box was secured with three numbered seals. These seal numbers, and initials of the technician who placed the seal on the door, are recorded on this form. A record of the seal numbers assigned to each location is kept by the Administrative Offices. If seals are replaced by the polling place judge during normal operation, those changes are documented here. The back of the form may be used to document additional information. A fourth seal is applied to the secure ballot transfer bag when the ballots are removed from the ballot box and transferred to the central counting station following the end of voting.
